Dhammaan qaybaha kala duwan ee Green Bay Metro ayaa looga baahan yahay inay soo gudbiyaan Barnaamijka Title VI si loo hubiyo ku-oolka Maamulka Federaalka Federaalka (FTA) wareega 4702.1B.

**A. Siyaasadda Dhibaato la'aanta**

Green Bay Metro waxay xaqiijineysaa in qofna uusan ku xirnayn jinsiyad, midab, ama asal qarameed, sida ku xusan Xeerka VI ee Xeerka Xuquuqda Dadweynaha ee 1964, iyo Xeerka Dib u Dhigista Xuquuqda Madaniga ee 1987, (PL 100.259) laga reebo kaqaybgalka in, loo diido faa'iidooyinka, ama lagu takooro barnaamij kasta ama waxqabadyada ay bixiso Green Bay Metro.

Xilka fulinta Title VI waa shuruud ah helitaanka maaliyadaha federaalka. Patricia Kiewiz, Agaasimaha Gaadiidka ee Green Bay, wuxuu u adeegayaa Isduwaha Xeerka VI waxaana loo oggol yahay inuu hubiyo in la fuliyo siyaasaddan iyo sharciga, oo ay ku jiraan shuruudaha Xeerka Federaalka Federaalka (CFR).

**B. Qeybinta**

**C. Nidaamka Cabashada**

#### QIIMEYNTA SIYAASADDA

Green Bay Metro waxaa ka go'an in ay jabiso caqabadaha luuqadda iyada oo hirgelineysa heerarka joogtada ah ee gargaarka luqadda ee ka jira aagga adeega.

**Tirakoobka.** Maraykanku wuxuu hoy u yahay malaayiin qof oo ka mid ah dadka laga tirada badan yahay oo ah LEP. Taasi waa luqaddooda koowaad aysan ahayn Ingiriis, mana hadli karaan, akhrin karaan, qori karaan ama fahmi karaan luqadda Ingiriisiga heer ay u ogolaanayaan inay si dhexdhexaad ah ula shaqeeyaan dadka qaata gargaarka maaliyadeed ee Federaalka. Sababtoo ah kala duwanaanshaha luqadda iyo karti la'aanta ku hadalka ama fahamka Ingiriisiga, dadka leh LEP waxaa laga yaabaa in laga saaro barnaamijyada ama waxqabadyada, la kulma daahitaan ama diidmo adeegyo. Shakhsiyaadkaasi waxay xaq u yeelan karaan kaalmo luqadeed marka loo eego adeeg gaar ah. Xukuumada Federaalka iyo kuwa gargaarka ka hela dawladda federaalku waa inay qaadaan tallaabooyin macquul ah si loo hubiyo in dadka LEP inay helaan faa'iido leh barnaamijyada, adeegyada, iyo macluumaadka hay'adaha ay bixiyaan. ## QIIMEYNTA FACTORS

Fikradda Tirada 1: Tirada ama saamiga dadka LEP ee aagga adeega. Inta badan dadweynaha aan ganacsiga sameyneyno (shakhsiyaadka raba in ay raacaan gaadiidka) waxay ku fiicanyihiin Ingiriis, sidaa darteed adeegyada LEP sida caadiga ah looma baahna.

1. Sida laga soo xigtay Sahanka Bulshada Mareykanka ee 2016, Ingiriisi wuxuu ku hadlayaa 89.4% midka shanaad ama ka weyn ee Gobolka Brown. Inta badan kuwa ku hadla luuqad kale waxay ku hadlaan Ingiriis.

2. Isugeyn 7,311 ama 3.1 boqolkiiba dadka ku hadla luqadda Isbaanishka ee Brown County waxay muujinayaan inay ku hadlaan Ingiriis ka yar "aad u wanaagsan".

3. Wadarta 2,222 qof ama boqolkiiba 0.9 oo ka mid ah dadka ku hadla Aasiya iyo Jasiiradaha Baasifigga ee ku yaala Gobolka Brown waxay muujinayaan inay ku hadlaan Ingiriis ka yar "si aad u wanaagsan". ACS waxay u aqoonsataa guud ahaan 280 luqadood oo Asia iyo Pacific Islander ah. Kuwa ugu caansan waa Shiinees, Japanese, Korean, Hmong, Thai, Laotian, iyo Vietnamese.

Green Bay Metro waxay xaqiijinaysaa barnaamijyo iyo waxqabadyada oo dhan dadka haysta aqoonta Ingiriisiga ee kooban. Kormeerka nidaamka waxaa loo sameeyaa si loo hubiyo in dhammaan baahiyada luuqadeed la buuxiyo. Xilligan la joogo rakaabku wuxuu ka kooban yahay kaliya afafka Ingiriisiga iyo Isbaanishka. Looma baahna dad kale oo LEP ah inay ku kulmaan xudduudaha Safe Harbor.

Green Bay Metro Qodobka VI iyo nidaamyada LEP iyo nidaamka cabashooyinka waxaa lagu dhejiyaa Xarunta Gaadiidka iyo shabakada internetka ee Metro.

Fikradda No. 2. Joogista ay shaqsiyaadka LEP la kulmaan adeegga. Dhamaan xiriirada Green Bay Metro waxaa lagu sameeyey Xaruntooda Metro ee ku yaalla Green Bay, WI. Dadka LEP waxaa maalin walba la adeegsadaa basaskayaga iyo adeegga jawaab celinta dalbashada dalxiiska. Xiriirrada LEP-ga waa mid aad u yar.

Fikradda No. 3: Dabeecada iyo muhiimada adeega ay bixiso Green Bay Metro. Green Bay Metro waxay bixisaa adeegyada muhiimka ah ee gaadiidka guud ahaan magaalooyinka si dadwaynaha ah iyada oo loo marayo jidkeeda go'an, adeegyo xadidan iyo barnaamijyo gaar ah.

Fikradda No. 4. Khayraadka la heli karo ee helaya miisaaniyada federaalka si loo hubiyo helitaanka macno leh ee adeega dadka LEP. Green Bay Metro waxay la kulantay shaqaale ku hadla luqada Isbaanishka waxayna ogolaadeen inay u adeegaan turjumaan markii loo baahdo waqtiyadaas marka qof aqoon u leh Ingiriisi xaddidan uu la xiriiro nidaamka gaadiidka. Dadaalka lagu hayo dadka leh caqabadaha luqadaha mar walba, Green Bay Metro waxay adeegsanaysaa adeega tarjumaadda shirkad qandaraas ah markii loo baahdo.
